A period of three year has been allocated for transition purposes in which laboratories can conduct a ISO 17025 transition to the 2017 version before the old version no longer is valid. In case of accreditation to this standard a laboratory makes it official that has got the required skill, fairness along with reliable setups at worldwide level.

Publication of ISO/IEC 17025:2017. Following three years of revision by ISO CASCO Working Group 44, the third edition of ISO/IEC 17025 (ISO/IEC 17025:2017) was published by ISO on 30 November 2017, and has been adopted by BSI as a British Standard. A copy of this new edition can be purchased from BSI Online. An ISO brochure has been published that summarises the key changes.

As a result of the recent ILAC ballot the transition period for ISO/IEC 17025:2017 adopted as part of the ILAC Resolution GA 20.15 (November 2016) has been extended from 30 November 2020 to 1 June 2021. This extension has been granted to ensure all accreditation bodies and the accredited laboratories are able to achieve the remaining transitions in a robust manner under the restrictions imposed as a result of the global coronavirus disease 2019 (COVID-19) outbreak.
