Nurses have a critical role to play in achieving the goal of health equity, but they need robust education, supportive work environments, and autonomy. The ultimate goal is the achievement of health equity in the United States built on strengthened nursing capacity and expertise. By leveraging these attributes, nursing will help to create and contribute comprehensively to equitable public health and health care systems that are designed to work for everyone.
