The analysis of the power sector shows how the country can expand power generation and broaden access to electricity while reducing the associated emissions. This low-carbon scenario would enable Nigeria to achieve the same long-term development objectives, at lower overall cost through a more diversified mix of generation sources with a more balanced supply across regions. Finally, this analysis assesses the expected growth in CO2 emissions from on-road transport under a normal business development scenario up to the year 2035 and identifies policy and other mitigation actions at national and local levels that would reduce this growth, resulting in fuel economies, better air quality, and reduced congestion.
