Constitution created the Supreme Court; Congress later created all lower courts. Judiciary's most important power, judicial review, was not named in Constitution but rather established in 1803 case Marbury v. Madison. The Judicial Branch of the federal government interprets and reviews the laws of the nation. The group that has the job of interpreting and reviewing the laws of the land is the Supreme Court. It is the highest court in the nation. The Supreme Court of the United States meets in the Supreme Court Building in Washington D.C.
