Practical, warm-hearted, and often witty, Eleanor’s answers were so forthright her editors included a disclaimer that her views were not necessarily those of the magazines or the Roosevelt administration. Asked, for example, if she had any Republican friends, she replied, “I hope so.” Queried about whether or when she would retire, she said, “I never plan ahead.” As for the suggestion that federal or state governments build public bomb shelters, she considered the idea “nonsense.” Covering a wide variety of topics—everything from war, peace, and politics to love, marriage, religion, and popular culture—these columns reveal Eleanor Roosevelt’s warmth, humanity, and timeless relevance.

During the Progressive Era, a time when the field of design was dominated almost entirely by men, a largely forgotten activist and teacher named Louise Brigham became a pioneer of sustainable furniture design. With her ingenious system for building inexpensive but sturdy "box furniture" out of recycled materials, she aimed to bring good design to the urban working class. As Antoinette LaFarge shows, Brigham forged a singular career for herself that embraced working in the American and European settlement movements, publishing a book of box furniture designs, running carpentry workshops in New York, and founding a company that offered some of the earliest ready-to-assemble furniture in the United States. Her work was a resounding critique of capitalism's waste and an assertion of new values in design—values that stand at the heart of today's open and green design movements.

An unorthodox historian known and respected for his work on the grand conflicts of nations and civilizations, John Lukacs has peopled a smaller canvas in this volume, with seven colourful figures who flourished in Philadelphia

before 1950. Their stories are framed by chapters that describe the city in 1900 and in 1950. The Philadelphians selected are a political boss, Boies Penrose; a magazine mogul, Edward Bok; an elegant writer, Agnes Repplier; an impetuous diplomat, William C. Bullitt; a lawyer, George Wharton Pepper; a prophet of decline, Owen Wister; and a great art collector, Albert C. Barnes. The political boss was perhaps the most monumental political figure of his age. The magazine mogul was the most famous embodiment of the American success story during his lifetime. The now almost forgotten writer was the Jane Austen of the essay. The diplomat was the most brilliant of ambassadors. The terrible-tempered collector was a radical proponent of his unusual theory of art. Through these seven portraits, Lukacs paints a picture of Philadelphia that is "like all living things, having the power to change out of recognition and yet remain the same." This work is a must read for all historians and Philadelphians.

Women have been important contributors to and readers of magazines since the development of the periodical press in the nineteenth century. By the mid-twentieth century, millions of women read the weeklies and monthlies that focused on supposedly "feminine concerns" of the home, family and appearance. In the decades that followed, feminist scholars criticized such publications as at best conservative and at worst regressive in their treatment of gender norms and ideals. However, this perspective obscures the heterogeneity of the magazine industry itself and women's experiences of it, both as readers and as journalists. This collection explores such diversity, highlighting the differing and at times contradictory images and understandings of women in a range of magazines and women's contributions to magazines in a number of contexts from late nineteenth century publications to twenty-first century titles in Britain, North America, continental Europe and Australia.

This anthology was compiled to aid the scholar working on the origins and evolution of jazz. Covering materials published through 1929, it also begins with articles from 1856 which do not concern jazz directly, but will serve to present a solid foundation for understanding the American music scene from which jazz developed. Chronologically listed and well-indexed, the hundreds of articles comprise, in effect, a history of jazz as it evolved. Beginning with accounts of negro music in the pre-jazz era, continuing in an exploration of spirituals, followed by a description of ragtime, we finally learn about the development of jazz from its practitioners and informed audiences of the time.

America's Changing Icons is a discursive examination of the female patriotic icon in the United States. Despite today's historically low maternal and infant mortality rates in the United States, labor continues to evoke fear among American women. Rather than embrace the natural childbirth methods promoted in the 1970s, most women welcome epidural anesthesia and even Cesarean deliveries. In *Deliver Me from Pain*, Jacqueline H. Wolf asks how a treatment such as obstetric anesthesia, even when it historically posed serious risk to mothers and newborns, paradoxically came to assuage women's anxiety about birth. Each chapter begins with the story of a birth, dramatically illustrating the unique practices of the era being examined. *Deliver Me from Pain* covers the development and use of anesthesia from ether and chloroform in the mid-nineteenth century; to amnesiacs, barbiturates, narcotics, opioids, tranquilizers, saddle blocks, spinals, and gas during the mid-twentieth century; to epidural anesthesia today. Labor

pain is not merely a physiological response, but a phenomenon that mothers and physicians perceive through a historical, social, and cultural lens. Wolf examines these influences and argues that medical and lay views of labor pain and the concomitant acceptance of obstetric anesthesia have had a ripple effect, creating the conditions for acceptance of other, often unnecessary, and sometimes risky obstetric treatments: forceps, the chemical induction and augmentation of labor, episiotomy, electronic fetal monitoring, and Cesarean section. As American women make decisions about anesthesia today, *Deliver Me from Pain* offers them insight into how women made this choice in the past and why each generation of mothers has made dramatically different decisions.
