This book is based on an honors course in advanced calculus that the authors gave in the 1960's. The foundational material, presented in the unstarred sections of Chapters 1 through 11, was normally covered, but different applications of this basic material were stressed from year to year, and the book therefore contains more material than was covered in any one year. It can accordingly be used (with omissions) as a text for a year's course in advanced calculus, or as a text for a three-semester introduction to analysis. The prerequisites are a good grounding in the calculus of one variable from a mathematically rigorous point of view, together with some acquaintance with linear

algebra. The reader should be familiar with limit and continuity type arguments and have a certain amount of mathematical sophistication. As possible introductory texts, we mention *Differential and Integral Calculus* by R Courant, *Calculus* by T Apostol, *Calculus* by M Spivak, and *Pure Mathematics* by G Hardy. The reader should also have some experience with partial derivatives. In overall plan the book divides roughly into a first half which develops the calculus (principally the differential calculus) in the setting of normed vector spaces, and a second half which deals with the calculus of differentiable manifolds. *Complex Analysis in one Variable* Springer Science & Business Media

In some sense, I think the classical German prewar texts were the best (Hurwitz-Courant, Knopp, Bieberbach, etc.) and I would recommend to anyone to look through them. More recent texts have emphasized connections with real analysis, which is important, but at the cost of exhibiting succinctly and clearly what is peculiar about complex analysis: the power series expansion, the uniqueness of analytic continuation, and the calculus of residues. The systematic elementary development of formal and convergent power series was standard fare in the German texts, but only Cartan, in the more recent books, includes

this material, which I think is quite essential, e. g. , for differential equations. I

have written a short text, exhibiting these features, making it applicable to a wide variety of tastes. The book essentially decomposes into two parts.

In some cases, the problems in the beginning chapters are used in later ones, for example, in Chapter IV when one constructs-bump functions, which are used to smooth out singularities, and prove that the space of functions is dense in the space of regulated maps. The numbering of the problems is as follows. Exercise IX. 5. 7 indicates Exercise 7, §5, of Chapter IX.
