Introduction to Law Enforcement: An Insider's View (5th Edition) is a very unique textbook. The author has compiled a distinguished career in both law enforcement and academia. In addition to being decorated for meritorious service and honored by his agency as Officer of the Year, Dr. Doerner also served two terms as the editor of the *American Journal of Criminal Justice*. The *Southern Criminal Justice Association* bestowed its Criminal

Justice Educator of the Year Award on him in recognition of his accomplishments in teaching, research, and service. In addition, the American Society of Victimology selected Professor Doerner as the recipient of its 2009 John P.J. Dussich Award, which recognizes excellence in research and the provision of services to crime victims over a substantial length of time.
