Homeless assistance has frequently adhered to the "three hots and a cot" model, which prioritizes immediate material needs but may fail to address the political and social exclusion of people experiencing homelessness. Loehwing's interrogation of homeless advocacy rhetorics demonstrates how discursive practices shape democratic culture and how they may provide a potential civic remedy to the harms of disenfranchisement, discrimination, and displacement.
