In *Theologizing Friendship*, the author aims to revitalize Jean Leclercq's defense of monastic theology, while expanding and qualifying some of the central theses expounded in *Leclercq's magisterial The Love of Learning and the Desire for God*. The current work contributes to a revised and updated status quaestionis concerning the theological relationship between classical monasticism and

scholasticism, construed in more systematic and speculative terms than those of Leclercq, rendered here through the lens of friendship as a theological topos. The predominant “stewardship model” of creation is the result of an intentional effort to correct approaches that reinforce human sovereignty and the resulting environmental degradation.

However, as All God’s Creatures argues, the stewardship model actually does not offer a

correction but rather reinscribes many of the very same pitfalls. After close analysis of the stewardship model, this book identifies scriptural, theological, and philosophical sources to support the adoption of a “community of creation” paradigm. The texts of these conferences represent the longest and most systematically organized of any of numerous series of conferences that Merton presented during the decade of his mastership. They may

be the most directly pastoral work Merton ever wrote.
