

had a top speed of 45 mph. It was a rear-wheel drive vehicle with wooden wheels, and featured a twospeed transmission plus a reverse gear. Although models varied - and installation of many revisions took camshaft bearings, place over two decades of production - the original version weighed about 1200 pounds.
