The next four parts deal with the classic areas of space flight operations: mission operations, communications and infrastructure, the flight dynamics system, and the mission planning system. This is followed by a part describing the operational tasks of the various subsystems of a classical satellite in Earth orbit. The last part describes the special requirements of other mission types due to the presence of astronauts, the approach of a satellite to another target satellite, or leaving Earth orbit in

interplanetary missions and landing on other planets and moons. The 2nd edition is published seven years after the first edition. It contains four new chapters on flight procedures, the human factors, ground station operation, and software and systems. In addition, several chapters have been extensively expanded. The entire book has been brought up to date and the language has been revised. This book is based on the "Spacecraft Operations Course" held at the German Space Operations Center.
