The rates quoted here are for the 2020/21 tax year (for previous years, visit our Tax Rates section). In fact, if you earn less than £169 per week, you are not liable to pay any NICs at all.

1. Employees' NICs. As an employee of your limited company, you pay Class 1 National Insurance Contributions. You pay 13.8% of earnings over £169 per week.

National Insurance contributions - Which? Class 3 National Insurance contributions are those that you can pay voluntarily. You may opt to do this if you have gaps in your record from previous years. These cost you £15.30 per week in 2020-21, up from £15 per week in

2019-20. Student National Insurance contributions. You don't start paying National Insurance until you're over 16-years-old.
