Dunne and Raby contend that if we speculate more—about everything—reality will become more malleable. The ideas freed by speculative design increase the odds of

achieving desirable futures.

Nevertheless, there is still no general history of natural disasters available in any language. This book aims to cover one grey area in historical studies, that is, spiritual responses and survival strategies of medieval man in front of natural disasters.
