Countering emerging threats is not based solely on defeating a nation-state's military forces by conventional, kinetic means. Fundamentally, these threats are met by understanding and manipulating the human aspects that drive the adversary's ideological narrative within the target population. The authors conclude that, instead of creating a separate human domain of operations, the services and the Joint Force should focus on better integrating human aspects of military operations.
