Eventually, the North had to grapple with the underlying cause of the war--slavery--and adopt a policy of emancipation as a second war aim. This "new birth

of freedom," as Lincoln called it, constitutes the proudest legacy of America's bloodiest conflict. This authoritative volume makes sense of that vast and confusing "second American Revolution" we call the Civil War, a war that transformed a nation and expanded our heritage of liberty.

This study also recommends capacity building, priority research, and institutional and global efforts to reduce the incidence and impact of birth defects in developing countries.

Gaussian Processes for Machine Learning A Manual for Writers of Research Papers, Theses, and Dissertations, Seventh Edition
John Lawson's amazingly detailed yet lively book is easily one of the most valuable of the early histories of the Carolinas, and it is certainly one of the best travel accounts of the early eighteenth-century colonies. An inclusive account of the manners and customs of the Indian tribes of that day, it is also a minute report of the soil, climate, trees, plants, animals, and fish in the Carolinas. Lawson's observation is keen and thorough; his style direct and vivid. He misses nothing and recounts all -- from the storms at sea to his impressions of New York in 1700, the trip down the coast to Charleston, and his travels from there into North Carolina with his Indian guides. The first edition of this work was

published in London in 1709. While various editions followed in the eighteenth century -- including two in German -- this edition is a true copy of the original and is the first to include a comprehensive index. It also contains "The Second Charter," "An Abstract of the Constitution of Carolina," Lawson's will, and several previously unpublished letters written by Lawson. A number of DeBry woodcuts of John White's drawings of Indian life, sketches of the beasts of Carolina which appeared in the original 1709 edition, and Lawson's map contribute additional interest to this volume.

Riparian Areas Penguin Classics

The Clean Water Act (CWA) requires that wetlands be protected from degradation because of their important ecological functions including maintenance of high water quality and provision of fish and wildlife habitat. However, this protection generally does not encompass riparian areas—the lands bordering rivers and lakes—even though they often provide the same functions as wetlands. Growing recognition of the similarities in wetland and riparian area functioning and the differences in their legal protection led the NRC in 1999 to undertake a study of riparian areas, which has culminated in Riparian Areas: Functioning and Strategies for Management. The report is intended to heighten awareness of riparian areas commensurate with their ecological and societal values. The primary conclusion is that, because riparian areas perform a disproportionate number of biological and physical functions on a unit area basis, restoration of riparian functions along America's waterbodies should be a national goal.

The Value of Academic Libraries Random House

This guideline provides updated global, evidence-informed recommendations on the intake of free sugars to reduce the risk of NCDs in adults and children, with a particular focus on the prevention and control of unhealthy weight gain and dental caries. The recommendations in this guideline can be used by policy-makers and programme managers to assess current intake levels of free sugars in their countries relative to a benchmark. They can also be used to develop measures to decrease intake of free sugars, where necessary, through a range of public health interventions. Examples of such interventions and measures that are already being implemented by countries include food and nutrition labelling, consumer education, regulation of marketing of food and non-alcoholic beverages that are high in free sugars, and fiscal policies targeting foods and beverages that are high in free sugars. This guideline should be used in conjunction with other nutrient guidelines and dietary goals, in particular those related to fats and fatty acids (including saturated fatty acids and trans-fatty acids), to guide development of effective public health nutrition policies and programmes to promote a healthy diet.

When the Akimotos Went to War CRC Press

At an event honoring Daisy Bates as 1990's Distinguished Citizen then-governor Bill Clinton called her "the most distinguished Arkansas citizen of all time." Her classic account of the 1957 Little Rock School Crisis, The Long Shadow of Little Rock, couldn't be found on most bookstore shelves in 1962 and was banned throughout the South. In 1988, after the University of Arkansas Press reprinted it, it won an American Book Award. On September 3, 1957, Gov. Orval Faubus called out the National Guard to surround all-white Central High School and prevent the entry of nine black students, challenging the Supreme Court's 1954 order to integrate all public schools. On September 25, Daisy Bates, an official of the NAACP in Arkansas, led the nine children into the school with the help of federal troops sent by President Eisenhower—the first time in eighty-one years that a president had dispatched troops to the South to protect the constitutional rights of black Americans. This new edition of Bates's own story about these historic events is being issued to coincide with the fiftieth anniversary of the Little Rock School crisis in 2007.
