Purpose: The purpose of this document is to implement the Office of Management and Budget's (OMB) Final Information Quality Bulletin for Peer Review (hereafter referred to as the Bulletin), which were issued on December 16, 2004, and published in the Federal Register on January 14, 2005 (FR 70:2664—2677).

Specifically, if an agency is responsible for disseminating influential scientific, financial, or statistical information, agency guidelines shall include a high degree of transparency about data and ...

OMB indicated that "quality" encompasses elements of utility, objectivity, and integrity, and said agencies can generally presume that data are "objective" if they have been subject to an independent peer review process. In April 2004, OMB provided Congress with a report on the implementation of the IQA during FY2003.

When agencies submit their draft agency guidelines for OMB review, agencies should include a description of the extent to which the reproducibility standard is applicable and reflect consultations with relevant scientific and technical communities that were used in developing guidelines related to applicability of the reproducibility standard to original and supporting data.
