The Third International Computer Science Symposium in Russia (CSR-2008) was held during June 7-12, 2008 in Moscow, Russia, hosted by Dorodnicyn Computing

Centre of Russian Academy of Sciences, Institute for System Programming of Russian Academy of Sciences, Moscow State University, Moscow Institute of Open Education, and Institute of New Technologies.
