You can get a dissolution if you have lived apart for more than 2 years, and both agree to end the civil partnership. Your civil partner must agree in writing to end the civil partnership. Lived apart from 5 years. If you have been living apart for more than 5 years it is usually enough to end a civil partnership, even if your civil partner disagrees.
