New in 2018, notaries public can also apply for an electronic records notary public endorsement, which

allows the notary to perform notarial acts on electronic documents as well as paper documents. The application process is similar to the application process for the commission, and can be done at the same time or separately.

According to agency officials and guidance posted on State's public website, applicants can apply for a U.S. passport in one of three ways: in person at an acceptance facility, by mail (for renewal applications), or at a passport facility that offers acceptance services (typically expedited applications). Applicants submit documents, such as a birth certificate or driver's license, to passport acceptance agents to provide

evidence of citizenship, or noncitizen nationality, and proof of identity. The acceptance agents are to watch the applicant sign the application, review submitted documents for completeness, and check for application inconsistencies.
