The "Powell Report" on the Uniform Code of Military Justice stresses military law's role of maintaining discipline in the Army: Discipline - state of mind which leads to a willingness to obey an order no matter how unpleasant the task to be performed – is not characteristic of a civilian community. Development of this state of mind among soldiers is a command responsibility and a necessity. In the development of discipline, correction of individuals is indispensable; in correction, fairness or justice is indispensable. Thus, it is a mistake to talk of balancing discipline and justice – the two are inseparable. Once a case is before a court-martial, it should be realized by all concerned that the sole concern is to accomplish justice under the law. This does not mean justice as determined by the commander referring a case or by anyone not duly constituted to fulfill a judicial role. It is not
