The major objective of a distributed system is to provide low cost availability of the resources of the system by localizing access and providing insulation against failures of individual components. Since many users can be concurrently accessing the system, it is essential that a distributed system also provide a high degree of concurrency. Research into algorithms has been focused on concurrency, consistency, failure detection, management of replicated copy, and commitment and termination of transactions. This book is a compilation of a subset of research contributions in the area of concurrency control and reliability in distributed systems, with brief explorations of interesting areas, including theoretical and experimental efforts.

This textbook examines database systems from the viewpoint of a software developer. This perspective makes it possible to investigate why database systems are the way they are. It is of course important to be able to write queries, but it is equally important to know how they are processed. We e.g. don't want to just use JDBC; we also want to know why the API contains the classes and methods that it does. We need a sense of how hard is it to write a disk cache or logging facility. And what exactly is a database driver, anyway? The first two chapters provide a brief overview of database systems and their use. Chapter 1 discusses the purpose and features of a database system and introduces the Derby and SimpleDB systems. Chapter 2 explains how to write a database application using Java. It presents the basics of JDBC, which is the fundamental API for Java programs that interact with a database. In turn, Chapters 3-11 examine the internals of a typical database engine. Each chapter covers a different database component, starting with the lowest level of abstraction (the disk and file manager) and ending with the highest (the JDBC client interface); further, the respective chapter explains the main issues concerning the component, and considers possible design decisions. As a result, the reader can see exactly what services each component provides and how it interacts with the other components in the system. By the end of this part, s/he will have witnessed the gradual development of a simple but completely functional system. The remaining four chapters then focus on efficient query processing, and focus on the sophisticated techniques and algorithms that can replace the simple design choices described earlier. Topics include indexing, sorting, intelligent buffer usage, and query optimization. This text is intended for upper-level undergraduate or beginning graduate courses in Computer Science. It assumes that the reader is comfortable with basic Java programming; advanced Java concepts (such as RMI and JDBC) are fully explained in the text. The respective chapters are complemented by "end-of-chapter readings" that discuss interesting ideas and research directions that went unmentioned in the text, and provide

references to relevant web pages, research articles, reference manuals, and books.

Conceptual and programming exercises are also included at the end of each chapter. Students can apply their conceptual knowledge by examining the SimpleDB (a simple but fully functional database system created by the author and provided online) code and modifying it.

This book is an anthology of the results of research and development in database query processing during the past decade. The relational model of data provided tremendous impetus for research into query processing. Since a relational query does not specify access paths to the stored data, the database management system (DBMS) must provide an intelligent query-processing subsystem which will evaluate a number of potentially efficient strategies for processing the query and select the one that optimizes a given performance measure. The degree of sophistication of this subsystem, often called the optimizer, critically affects the performance of the DBMS. Research into query processing thus started has taken off in several directions during the past decade. The emergence of research into distributed databases has enormously complicated the tasks of the optimizer. In a distributed environment, the database may be partitioned into horizontal or vertical fragments of relations. Replicas of the fragments may be stored in different sites of a network and even migrate to other sites. The measure of performance of a query in a distributed system must include the communication cost between sites. To minimize communication costs for-queries involving multiple relations across multiple sites, optimizers may also have to consider semi-join techniques.
