If a company earned profits in a country where they were taxed at a rate of just 10 percent, the U.S. tax rate on those profits would be 11 percent, which is the current rate of 21 percent minus the 10 percent paid in foreign taxes. Unpaid Tax Problem. Having unpaid taxes can lead to several different types of tax problems.

Immediately upon realizing that you have unpaid taxes (if you have not already come to some form or settlement or agreement), the IRS will begin its collection system. As soon as the collection system begins, the IRS begins to charge penalties and interest. As time goes on and taxes remain unpaid, the IRS collection actions become increasingly more aggressive and create additional tax problems.
