Each bank has a slightly different process regarding proof of address - but in general, you'll be asked to show 1 or 2 original documents which prove your residential address. These usually have to be from official sources, such as a driving license, or council tax bill<sup>1</sup>. What documents count as proof of address?

Although the legitimacy of the proof of address document is often vaguely defined it is still one of the basic requirements for KYC/AML checks When a user wants to create an account or make a transaction, in order to get verified they need two submit two most commonly asked documents—proof of identity and proof of address (PoA).
