

Artificial intelligence is already all around us, from

The fourth industrial revolution, says Schwab, is more significant, and its ramifications more profound, than in any prior period of human history. Schwab also offers bold ideas on how to harness these changes and shape a better future—one in which technology empowers people rather than replaces them; progress serves society rather than disrupts it; and in which innovators respect moral and ethical
