Inorganic Solid Fluorides: Chemistry and Physics deals with the chemical and physical properties of inorganic solid fluorides and covers topics ranging from methods used in the preparation of fluorides to the crystal chemistry of fluorides and transition metal oxyfluorides. Fast fluorine ion conductors and nonlinear properties of fluorides are also considered. The final chapter is devoted to industrial uses of inorganic fluorides. This monograph should be of interest to physicists and inorganic chemists as well as students of physics and inorganic chemistry.
