Numerous examples of command lines and full programs are provided throughout for various software packages, including Maple, Sollya, and Gappa. New to this edition are an in-depth overview of the IEEE-754-2008 standard for floating-point arithmetic; a section on using double- and triple-word numbers; a presentation of new tools for designing accurate function software; and a section on the Toom-Cook family of multiplication algorithms. The techniques presented in this book will be of interest to implementers of elementary function libraries or circuits and programmers of numerical applications. Additionally, graduate and advanced undergraduate students, professionals, and researchers in scientific computing, numerical analysis, software engineering, and computer engineering will find this a useful reference and resource.
