In Six Amendments Stevens focuses, as promised, on nonvoter expenditures, which he thinks produce their own kind of corruption: "Unlimited expenditures by nonvoters in election campaigns ... impairs the process of democratic self-government by making successful candidates more beholden to the nonvoters who supported them than to the voters who elected them" (p. 78).
