Chapter 3 highlights the challenges faced in open-and distance learning teacher education contexts. Several of the chapters disseminate research findings on alternative interventions to classic WIL, namely, where “safe spaces” or laboratories are created for student teachers to learn and grow professionally. These could either be simulations, such as software programmes and avatars in the intervention described in Chapter 2; student excursions, as the findings in chapters 5, 7 and 10 portray; or alternative approaches to WIL (e.g. Chapters 11 and 12). The book is devoted to scholarship in the field of pre-service teacher education. The target audience is scholars working in the fields of pre-service teacher education, work-integrated learning, and self-directed learning. The book makes a unique contribution in terms of firstly its extensive use of Cultural-Historical Activity Theory as a research lens, and secondly in drawing on various theoretical frameworks. Both quantitative and qualitative research informed the findings of the book.

The copied file is automatically assigned the highest existing file number plus one. The comment, if any, with the O-word (i.e., in the first block of the program) will be displayed in the

COMMENT column of the card directory. To write all programs, type -9999 as the program number. In this case, if file name is not specified, all the programs are saved in file name PROGRAM.ALL on the memory card. A file name can have up to 8 characters, and an extension up to 3 characters (XXXXXXXXX.XXX). Repeat the last three steps to copy more files. Finally, press the CAN soft key, to cancel the copying mode and go to the previous menu.
