The Tax Policy Center estimates this would

reduce the number of itemizers from 45 million to 18 million in 2017, meaning fewer filers would benefit from the state and local tax deduction. The plan would also cap itemized deductions at \$100,000 for single filers and \$200,000 for joint filers, which would reduce the value of the SALT deduction for affected taxpayers.
