The FTC has sought public comments on a series of proposed changes to the Rule (formally known as the Used Motor Vehicle Trade Regulation Rule), which requires car dealers to display a window sticker, or "Buyers Guide," on used cars offered for sale. The Guide discloses whether the dealer is offering to sell a used car "as is" (without a warranty), or with a warranty.

In place since 1985, the Used Car Rule requires dealers to display in the window of used vehicles a sticker called a Buyers Guide that contains information about

warranties and other specific matters of interest to used car shoppers. A few years back, the FTC put the Rule under the regulatory microscope.

The Federal Trade Commission Buyers Guide Rule is part of a Federal Disclosure law that requires all used car dealers to disclose warranty information in writing before the

sale of any vehicle. The rule was placed into effect to inform consumers that the written warranty overrides and supersedes any spoken promises made by a motor vehicle dealer at the time of the sale.
