It is the environment rather than humankind itself that must be changed if the traditional goals of the struggle for freedom and dignity are to be reached. *Beyond Freedom and Dignity* urges us to reexamine the ideals we have taken for granted and to consider the possibility of a radically behaviorist approach to human problems--one that has appeared to some incompatible with those ideals, but which envisions the building of a world in which humankind can attain its greatest possible achievements.
