You may have seen it, but it's time to find out what et al. means and how to use it. Et al. is an abbreviation for et alia (neuter plural). But it can also be an abbreviation for et alii (masculine plural), or et aliae (feminine plural). This phrase means "and others."

For example, in a bibliography, rather than listing five authors of a scientific paper, we can list the first author's name and then use et al. for the remaining four authors. Et al. always refers to people – not things. Doug was suggesting the use of et al. to avoid greeting a list of people. He is wise to avoid a salutation like this:

Et al. does not need to be italicized in normal use. It does take a period after the second word, even when it falls in the middle of a sentence. In general, et al. is best reserved for citations and other parenthetical remarks in academic or other types of formal writing.

Rules for using et al. vary among different types of writing and publication requirements. The most common use of et al. is in citations that academic writers use when they refer to the work of other authors and researchers. Using et al. makes it easier to refer to books or articles

that have many authors.

To use et al., keep in mind that the Latin phrase means "and others" to help you decide where and when to use it. You can use et al. formally when you're creating in-text citations and parenthetical remarks so that you don't have to list a long string of names.

"Et al." is a Latin term that means "and others," and is used for in-text citations of works with multiple authors. The guidelines for using "et al." vary slightly among the three major formatting styles. MLA uses "et al." for works with

three or more authors, while Chicago calls for using it with four or more authors.

It is the abbreviated form of the Latin expression et alia (or et alii or et aliae, the masculine and feminine form of the plural, respectively). It is generally used in footnotes and citations: for example, when a book has multiple authors, et al. can be used after the first name to indicate that there are more than two other authors who ...

1. Writers sometimes use the surname of the first author followed by et al. at the first mention of a work that has three, four, or five authors. Only when a work has six or more authors should the first in-text citation consist of the first author followed by et al.

in place of a list of names, whether of people or places, when the list would be exhaustive, or is simply not necessary. The most common use of et al. is found in essays, research papers, and legal writings.

When there are six or more authors, cite the first author followed by “et al.”. When a source has three, four, or five authors, list all authors the first time the source is cited. In all subsequent citations, give only the first author followed by “et al.”.

Et Al. | Definition of Et Al. by Merriam-Webster

The phrase "et al."—from the Latin et alii, which literally means "and others"—must always be typed with a space between the two words and with a period after the "l" (since the "al." is an abbreviation). A comma does not follow the abbreviation unless the sentence's grammar requires it.

When To Use Et Al

For any source with more than two authors, type out the first author's last

name followed by "et al." Follow this format for the first and subsequent citations of the source. Example for a source with three authors, Rasmussen, Hopkins, and Fitzpatrick: Research plays a vital role in development planning (Rasmussen et al., 2004).

In-text citation format with et al. The phrase "et al." is used with in-text citations only when referencing a source that has three or more authors. Include the name of only the first author's last name plus "et al." in every citation.

When to use et al. in APA citation style | EasyBib

Et al. is most commonly found in scholarly writing, especially when used to avoid having to list a number of different authors in a bibliography or footnote. You can use it when describing the people who came to a dinner party, but it may sound rather odd.

How do I use et al. in APA? - Quick Answers

In APA 7, for a work with three or more authors, list the first author and "et al." for all citations, including the first citation, unless doing so would create ambiguity.

continuation of a list of people (not, as a general rule, of things). A period belongs after the l in et al. (but not after the t).
