Eligibility Requirements The Florida WIC Program is designed to serve certain categories of women, infants, and children. The eligibility prerequisites for WIC are based on those categories, state of residence, income, and nutritional needs. Applicants must live in the state of Florida.

WIC Laws and Regulations | USDA-FNS

The WIC PreScreening Tool assists applicants in determining whether or not they are potentially eligible to receive WIC benefits. This PreScreening Tool is not an application for WIC benefits. To apply for WIC benefits, you must make an appointment at a WIC local agency in

the State or area where you live.

You must have a total household income equal to or less than the amounts shown in the WIC Income Guidelines OR you are income-eligible if you are currently receiving Medicaid, Temporary Cash Assistance (TCA), or Food Assistance. However, you do not have to be on a public assistance program to qualify for WIC.

### **Florida WIC Income Guidelines**

WIC Legislative Requirements are contained in Section 17 of the Child Nutrition Act of 1966. Healthy, Hunger-Free Kids Act of 2010 Regulations. WIC Regulations are published

by the Federal Register in the Code of Federal Regulations, 7 C.F.R. Part 246. The CFR is updated with files with an effective date as of January 1 each year.

If you are looking to apply for WIC, then your household income will be taken into consideration when determining if you are eligible to receive Florida WIC benefits. To be eligible, applicants must have income at or below an income level or standard set by the state agency.

To be income eligible for Florida WIC benefits you must have a total household income equal to or less than the amounts shown in the Florida WIC Income Guidelines, or you are automatically income eligible if you are currently receiving Medicaid, Temporary Cash Assistance (TCA), or Food Assistance.

WIC guidelines require that candidates schedule a doctor's appointment to estimate nutritional risk. The nutritional risk assessment is one of the most significant qualifications requirements and one of the prime ways that WIC differs from other food assistance programs.

The state agency's income standard must be between 100 percent of the federal poverty guidelines (issued each year by the Department of Health and Human Services), but cannot be more than 185 percent of the

federal poverty income guidelines.

*Women, Infants and Children (WIC) | Florida Department of ...*

The Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) provides federal grants to states for supplemental foods, health care referrals, and nutrition education for low-income pregnant, breastfeeding, and non-breastfeeding postpartum women, and to infants and children up to age five who are found to be at nutritional risk.

WIC requirements also include residency. Florida benefits are not extended to anyone who lives outside of Florida. If you do live outside of Florida, you must learn how to get WIC in your own state, even if

you work within Florida. The final WIC qualification that you should be aware of is nutritional risk.
