Guide for applicants: PCT procedure before the EPO (Euro-PCT Guide) Amendments under Article 19 PCT are published by the IB. They are particularly useful if there is a reason to better define the scope of the claims for the purpose of securing provisional protection in the PCT contracting states offering it (see point 5.16.002). If the applicant wishes to file amendments to the claims, he must submit a complete set of the claims in replacement of all claims originally filed.
